

The traditional understanding of human rights limits their scope to the state's territory. Increasingly, this notion is challenged due to the impact of the activities of states beyond their borders. "Welcome Centres" for refugees in third countries and readmission agreements or mobility partnerships are just one recent example of extraterritorial effects on human rights which shift responsibilities. The increasing importance of analyzing the relevance and application of human rights beyond borders has been reflected, inter alia, in the discussion about Extraterritorial Obligations (ETO) of



states concerning human rights. However, the normative foundation of states' extraterritorial human rights obligations, their political and legal contents as well as the impact of this concept on different actors including private enterprises and international organisations remain disputed.

The international and interdisciplinary conference "Human Rights Beyond Borders" organised by the Centre for Human Rights Erlangen-Nuremberg (CHREN) of Friedrich-Alexander University Erlangen-Nürnberg addresses these questions and assesses central phenomena of the extraterritorial scope of human rights. Speakers include distinguished international scholars and experts in philosophy, political science, law and education as well as representatives of national human rights institutes and non-governmental organisations. The conference is open to academics, including young researchers, civil society and interested members of the public.
